Memorandum of Understanding (MOU)

First Party: Kurdistan Engineers Union (KEU), represented by Mr. Abdulrahman Ali Kurda.

Second Party: European Technology and Training Centre (ETTC), represented by Mr. Jihad Zero.

Article 1

Both parties agreed to combine their efforts and focus on building and strengthening scientific, professional, administrational capacities of Kurdistan engineers through institutional development support and training courses in various engineering and administrational fields with the aim of proceeding the process based on the engineers' requirements and suggestions.

Article 2

The plan of any activities that are found necessary to be implemented, based on this MOU, an official signed agreement should be made for any later activities. The programs should be updated in accordance with the achievement of the aim and both parties' assessments of the prior activities' outcomes.

Article 3

Both parties shall strengthen their relations in order to implement this MOU and strengthening our capacities by utilizing human resources and available technologies.

Article 4

Both parties appoint responsible and decision-making committee/representative to collaborate, supervise the project, and to process daily ongoing activities and tasks of the project. In case of necessity, daily documents, activities and information will be shared between the two parties.

Article 5

The cooperating parties shall share any results achieved at all times upon request. Both parties shall contribute with needed information to the financial and final report of the project.

Article 6

None of the parties shall have the right to represent the other party with respect to any legal relations or to issue legally binding declarations on the other parties' behalf.

Article 7

In case of any change in the program or project activities, the collaborating parties and the donors should be informed to agree and confirm the changes.

Article 8

The joint steering committee that supervises the projects should meet and discuss the status of the projects and analyse it at regular intervals. They have to be documented with approval signature on them.

Article 9

This MOU is written in Kurdish and English and both versions will be signed. This MOU will be translated to English, and both languages will be a source to solve any misunderstandings and disputes according to the type of documents and the language used.

Article 10

In event of objections from one or both parties on a subject or a condition that creates misunderstanding or disagreement, mutual decisions on this MOU will be made without any announcement or taking any legal procedure by neither cooperating party.

Article 11

For any project or activities, a tailor-made agreement will be signed by both parties and their contractors. Any changes and amendments, if necessary, it must have both parties' and donors' approval based on this MOU and mutual agreement on the projects. These joint agreements represent an inseparable part of this MOU.

For enriching or eliminating any insufficiencies of this MOU, the joint steering committee is authorized to discuss the suggestions and make necessary decisions accordingly.

Article 14

The MOU enters into efficiency on (09/05/2022) after it is signed by both parties, it is made in two languages (Kurdish and English) and in two copies; each cooperating party shall receive one copy.

Topic: Both parties, based on the MOU signed on Monday (09/05/2022), agreed on below mentioned points. This contract contains the package of the project in its first phase intitled (Capacity Building Measures with the Kurdistan Engineers Union and Establishment of an Engineers' Academy).

First Phase: List of activities:

- 1. A training course on establishing and managing engineering office will be held on (8, 10/05/2022)
- 2. Conducting project launch conference on Monday 09/05/2022.
- 3. Conducting up to 10 training courses in different engineering fields for 200 engineers.
- 4. Providing in-kind grants for 20 engineers who are interested to be placed on job or start a business (opening engineering consulting office).
- 5. Providing a Training of Trainers (ToT) training course for (15) members of KEU.
- 6. Presenting all participating engineers in the training courses with a gift.
- 7. Providing certificates to all participating engineers in the training courses.
- 8. Arranging a study visit which is coved by the project fund for a group of engineers and KEU members to Germany with a guarantee to ensure all participants will return to Kurdistan Region after the study visit.
- 9. In case any amount is left from the allocated budget after conducting all the project activities, the amount left will be spent on other activities within the project frame, and it will be discussed on in-between both parties.
